New Planning Guide for Professional Development

The tool is designed to guide the development of specific goals related to professional development that supports high quality inclusion.

Results of Previous Website Poll

Our latest poll asked: Does your state's quality rating system for child care programs include dimensions of quality related to serving children with disabilities? Most respondents (60%) were uncertain or did not believe that their state's quality rating systems for child care programs included dimensions of quality related to serving children with disabilities. Of the states that have developed Quality Rating Improvement

Systems (QRIS), only a few states include standards that address the needs of children with disabilities and their families within general QRIS standards. More details will be available in an upcoming concept paper from NPDCI describing the importance of program quality for early childhood inclusion, with recommendations for professional development.
